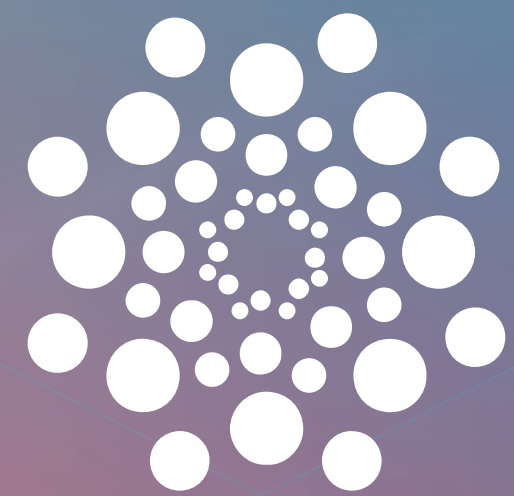

Select best business models/cases for test and learns and execute pilots with defined KPIs

Based on outcome of pilots inform policy and regulation .changes to scale solutions

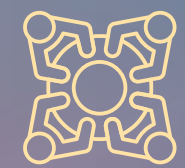

2022

- **Launch iHub** - 360 marketing plan including CHI innovation conference
- **Form iHub Governance** - Form Governance and Steering teams
Identify founding partners for iHub
- **iHub Roadshow** - Conduct iHub awareness sessions internal and external and sign up founding members
- **Capture challenge statements/idea** within CHI and from the sector
- **Launch iHub Innovation challenges** and execute pilots with startups.
- **Scale Up** - Help scale up successful pilots through exclusive agreements with CHI and facilitate access to funding.

2023

- **Partner with co working space** - Provide iHub startups with co working space
- **Launch CHI Innovation challenges** as cohorts of iHub accelerator and execute pilots
- **Establish funding model** for investing in startups
- **Develop innovation and entrepreneurship programs** with universities
- **Expand iHub beyond Health Insurtech** to all Insurtech

2024

- **Internationalize CHI innovation activities** through attending speaking at global innovation conferences, developing case studies
- **Partner with international accelerators** and launch global innovation challenges and execute pilots examples

How - iHub Membership Benefits

iHub will be co funded by paid membership from HICs, HCPs and CHI which will be renewed on a yearly basis.
